Description: Mercedes-Benz USA is recalling certain Model Year (MY) 2010-2011 C-Class (204), 2010-2012 GLK-Class (X204), 2010-2011 E-Class Coupes and Cabriolet (207), and 2011-2015 SLS-Class (197) Mercedes-Benz vehicles equipped with front passenger-side airbags affected by the defect decision of TK Holdings, Inc. (Takata). Under certain circumstances during a crash that necessitates passenger-side airbag deployment, the defect in your front passenger-side airbag inflator may cause the inflator housing to explode. $\hat{A} = \hat{A} + \hat{A}$

According to Takata, in the event of an inflator explosion, metal fragments could pass through the air bag cushion material, which may result in injury or death to vehicle occupants.
